Dear VBAlert Subscriber:

The City of Virginia Beach is transitioning its emergency alert and warning system, VBAlert, to a new platform powered by RAVE Mobile Safety. Because this is a new system, we are unable to transfer current subscriber's accounts. Therefore, you will need to create a new account by September 30th, 2019 to continue to receive VBAlert's. The new system allows for text, email and voice notifications.

Events that could prompt a VBAlert message include, but are not limited to:

- weather watches and warnings
- evacuation notifications
- rabid animal alerts
- hostage/barricade situations
- hazardous material spills
- boil water advisories
- traffic accidents with major delays

With the new platform, residents and visitors can also create a Smart911 profile to provide additional information to first responders if you ever call 9-1-1.

September is National Preparedness Month — Are You Ready?

This annual nationwide effort is designed to encourage year-round emergencies preparation.

It's been nearly three years since Hurricane Matthew — one of the most destructive natural disasters in Virginia Beach's history. Such storms, as well as winter blizzards and other natural disasters, illustrate the pressing need for everyone to be ready for a variety of emergencies.

How do you do it?



Get a Kit:

It is now the height of hurricane season, but citizens need to be prepared for all hazards, emergencies and extended power outages by having an <u>emergency supply kit</u> on hand. If you don't have one already, you can start building your emergency kit with these essential items:

- three—day supply of food that won't spoil, such as canned goods and packaged foods
- three–day supply of water, one gallon per person per day
- a hand crank or battery-powered radio with extra batteries
- a written family emergency plan
- a portable battery pack for your mobile phone

Once you gather these basics, put them in waterproof containers that you can carry or roll in case you need to leave your home quickly. Old suitcases or backpacks also work well and can hold supplies. Other useful items you may want to include:

- flashlights with extra batteries (not candles)
- manual can opener
- first aid kit
- list of prescriptions, doctors' contact information and a supply of medications for all family members including pets
- food and water for your pet(s)
- an extra pair of eyeglasses/contact lenses
- special items for babies, disabled or older family members
- cash in case ATMs are down/empty and banks are closed

Household Fences—Changes to Virginia Code

Virginia Code Title 55 was superseded by the new Title 55.1 (Property and Conveyances) enacted by Senate Bill 1080 in the last General Assembly session. Title 55.1 consists of 29 chapters divided into five subtitles: https://law.lis.virginia.gov/vacode/title55.1/

Subtitle I (Property Conveyances), Subtitle II (Real Estate Settlements and Recordation), Subtitle III (Rental Conveyances), Subtitle IV (Common Interest Communities), and Subtitle V (Miscellaneous).

A suggested read by leadership of civic leagues, community associations, etc., in particular is the section on fences: **Article 6. Division Fences**

§ 55.1-2821 (Effective October 1, 2019) Obligation to provide division fences

Adjoining landowners shall build and maintain, at their joint and equal expense, division fences between their lands, unless one of them chooses to let his land lie open or unless they agree otherwise.

City's Battery Recycling Program is Energized for Change

Here's some good news! Virginia Beach residents will be happy to know that they can now dispose of their standard alkaline batteries (AA, AAA, C, D and 9 volt) in their household trash. Alkaline batteries no longer contain mercury, which was one of the reasons for Public Works Waste Management accepting them in their Household Hazardous Waste (HHW) program. After many years of successfully collecting batteries from City buildings and recycling centers, Waste Management has determined that it is a fire hazard to continue to collect rechargeable batteries such as Lithium Ion (Li-Ion), Nickel Cadmium (NiCd), Nickel Metal Hydride (Ni-MH), and Nickel Zinc (Ni-ZN) batteries using the current system. With these changes comes the removal of the household battery collection boxes from all City libraries and recycling drop-off centers. Residents can properly dispose of their rechargeable batteries at the Virginia Beach Landfill and Resource Recovery Center, located at 1989 Jake Sears Road, with local retailers, such as Lowe's and Home Depot, or visit www.Call2Recycle.org for battery recycling locations nearest them. SINGLE-USE ALKALINE BATTERIES (AA, AAA, C, D, 9V)

Because these batteries no longer contain mercury, you can dispose of them in your household trash!

RECHARGEABLE BATTERIES (Li-Ion, Ni-Cd, SSLA/Pb, Ni-MH, Ni-ZN)

Proper disposal is very important as these pose a fire hazard if not handled with care. NEVER put these in the trash.
